- 1. Establish Quorum and Call Meeting to order (Pat Book)
- 2. Welcome and introduction of new Board members and Officer

3. Introduction of Guests:

- a. Deputy Sergeant, Steven Doddler, AZ Rangers, Peoria Company (www.azrangers.us);
 (719) 661-1978; sdodder@azrangers.us. Duty Sergeant Dodder reached out to the SCW LGBT Club via our club email offering to introduce himself & the AZ Rangers.
 - i. Handout of information. Attachment 1 to these minutes includes the organizational overview.
 - ii. Supports the NW valley includingPeoria, Glendale, Wickenburg. 500 officers in 20+ companies where they can provide non-profit and other organizations protective services support; they are a 501-C3 organization.
 - iii. The AZ Rangers are aware of increases in violence against the LGBT community and other communities but are unaware of such issues in the local area. Should a member or the club need assistance, please contact them.





iv. Community Event Safety, does the AZ Rangers support security for an event? They don't support a business such as a bar but they do support social functions even an LGBT board meeting. The AZ Rates are more economical such as \$25/hour whereas an off-duty officer may charge \$65-70/hour. They are always armed in providing security. If we choose to hire them, we execute a 1 page service agreement.

- b. Spanish Club IT Jerry Johnson & Treasurer, Cindy Larsen regarding the Corsizio tool use for e-commerce.
 - i. Jerry Johnson, IT director.
 - 1. The Club looked for ways to streamline payments, and during the pandemic, they stopped accepting cash payments, only check payments.
 - 2. Corsizio is used for classes, textbooks, fiestas, and membership.
 - 3. The Spanish Club canvassed all charter clubs, and many use Pay Pal, and the Art Club used Corsizio. The Art Club has all of their classes listed online via Corsizio which manages online registration.
 - 4. Corsizio, a Canadian business, is a free web-based software tool designed to support non-profits for online usage. There is a fee-based if more than 50 instances.
 - 5. For the Spanish Club, they made "Membership" a year-long event so it appears to be a class, but it is truly for Membership. Users can adapt the software.

 Members can either pay their membership fees via USPS or online for credit.
 - 6. On the LGBT site, we would embed the payment link/URL to facilitate online payments.
 - ii. Cindy Larsen, Treasurer
 - 1. Can use for paid and non-paid events.
 - 2. Current Club Usage: 10% mail in checks; 90% use credit cards
 - 3. Payment (Debit & Credit). Corsizio works with Stripe, a credit card payment processor. Corsizio bills \$0.10/transaction after 50 transactions/month plus \$1/transaction for each transaction or as a pay-as-you-go pricing for 2.9% + \$0.30. 

Attachment #1: Arizona Rangers Information Sheet

The 500 +/- Member Arizona Rangers operates throughout the State of Arizona through 20+ satellite companies, which are the equivalent of separate posts of the same organization. In other words, the Companies are not separate legal entities. The Companies are known by the name of the organization and the geographical areas from which a particular Company draws its members. For example the Company primarily based in the NW area of the Phoenix Valley is known as the Arizona Rangers - Peoria Company.

In 1901, the Arizona Rangers were created to rid the Arizona Territory of outlaws and corruption. Modeled after the Texas Rangers, the Arizona Rangers were tasked with hunting down and arresting outlaws in the Territory. The modern-day Arizona Rangers are an unpaid, all volunteer, non-profit 501(c)(3), law enforcement support and assistance civilian auxiliary in the State of Arizona who work cooperatively at the request of and under the direction, control, and supervision of established federal, state, or local law enforcement officials and officers. They also provide support to youth and youth activities throughout the State, while providing support to civic and community organizations.

As an armed uniformed volunteer law enforcement auxiliary, the Arizona Rangers can provide additional manpower at the request of any federal, state, county, or local law enforcement authority.

In 2002, the modern-day Arizona Rangers were officially recognized by the State of Arizona when the Legislature passed **Arizona Revised Statute (ARS) 41-4201** authorizing the Arizona Rangers to provide armed law enforcement assistance to any Local, State, Federal or Tribal law enforcement agency in Arizona, which was then signed into law by Governor Jane Hull amending ARS Title 41 – State Government. In addition, the **Arizona Rangers are exempt from private security regulations under ARS 32-2606 authorizing the Rangers to provide armed security services for a variety of nonprofit organizations.**

All Arizona Rangers undergo state and national background checks and investigations, must hold a current Arizona Concealed Weapon (CCW) Permit and must successfully complete the Arizona Ranger Training

Academy (ARTA). Rangers are certified to carry collapsible batons, OC spray, and meet Arizona POST qualification standards in firearms. They also receive Arizona POST training in handcuffing and defensive tactics. Many Arizona Rangers have previous law enforcement and/or military experience.

UNIFORMED, BADGED & ARMED or PLAINCLOTHES & ARMED

Some of the events that the Arizona Rangers have provided armed security for include:

- Civic festivals / Community event security / National Night Out security
- Bike race & marathon security and safety / Parades and holiday events / Sport Events
- Uniformed executive protection details / Church Security / Board, Civic and Social meetings, and events
- Dinners / Banquets / Weddings / Auto Shows / Trade Shows / Political Meetings & Events

Additional Security Services the Arizona Rangers have provided include:

- Security Patrols / Hostile Employee Threats / Business Security / Medical Clinic Security
- Personal & Executive Protection / Homeowner Association Patrols
- Peacekeeping / Traffic control on private property / Augment existing law enforcement patrols

The following is a summary of the minimum requirements for admission into the Arizona Rangers. Requirements beyond those indicated below will be identified during the recruitment and probationary periods. AZ Rangers pay individually for all of their uniforms, equipment & firearms.

- Be at least 21 years of age with no criminal history
- Reside in Arizona for at least six (6) months of the calendar year
- Hold a valid Arizona Concealed Carry Weapon (CCW) permit
- Sincerely subscribe to the mission and objectives of the Arizona Rangers
 - Successful completion of a background check and oral board
 - Meet physical fitness requirements
- Successfully graduate from the Arizona Ranger Training Academy (ARTA)
