1. Quorum established and called meeting to order by Patty at 5:30 p.m.

2. Approval of Prior Board Meeting Minutes held 10/2/23. Jim presented the minutes and the board approved them unanimously as presented.

- Of the 60 RSVPs, 39 members attended the 11/04/2023 General Meeting. There were 18 no-shows, or 30%, our highest level to date.
- 5. Book Group (Dave). The Book Group convenes on Thursday 11/09/23 and is reading "Last Night at the Telegraph Club".
- 6. Badges (Susan). The company "Be Can Do Engraving" in Sun City continues to create badges for the Club however their turnaround is slower than before.

7. Old Business

- a. Review of November 4 General Membership Meeting & Social (Laurel & Board)

 - 1. 60 members sent a Yes as the RSVP which is about 52% of the membership.
 - 2. Of the 60, only 39 attended, with 18 no-shows (there were some late cancellations). The No Show Rate was 30%, and only 34% of the total members attended the event (39 of 114)
 - ii. Budget. The Budget is presented in the Treasurer Report on Page 1.

It was discussed that many attendees are those members which have recently moved into SCW whereas many of the members with greater residency tenure are not attending Club activities.
